SUBMISSION OF UNDERTAKING BY RESIGNEES' (WHO ARE LIVING ABROAD) TO JOIN PENSION SCHEME UNDER THE BANK EMPLOYEES' PENSION REGULATION, 1995.

The detailed guidelines regarding EXTENDING AN OPTION OF PENSION TO THE RESIGNEES' WHO WERE OTHERWISE ELIGIBLE TO JOIN PENSION SCHEME UNDER THE BANK EMPLOYEES' PENSION REGULATIONS, 1995, were circulated vide PF & Pension Division Circular no. 06/2024 dated 16.04.2024.

In terms of aforementioned circular, all eligible former employees / officers (Resignees') and their surviving spouse or eligible family members will have to exercise their option by visiting and submitting documents in any branch of PNB in India **within ninety days of announcement (i.e. from 16.04.2024, date of issuance of circular) of such option as a one-time measure only.**

In this regard, we are receiving various queries from Resignees' / their surviving spouses / eligible family members who are currently living abroad and unable to visit any branch at India for submission of documents as mentioned in the said circular.

In view of the above, Resignees' / their surviving spouses/ eligible family members residing abroad have to get the duly filled documents mentioned in said circular attested by an officer of the PNB / Subsidiaries Bank of PNB/ Notary of the country/ an authorized official of the Indian Embassy/ High Commission of India or Consul of Indian Consulate in the country where the Resignees / their surviving spouse / eligible family members are presently residing.

Further, Scanned copy of attested documents to be sent directly to HO PF & Pension Division through email at pension@pnb.co.in and to any Branch of PNB in India where Resignees' / their surviving spouses/ eligible family members want to submit their pension option.
